### **Ribbons Awarded 1<sup>st</sup> to 6<sup>th</sup>**

**3 High Point Neck Garlands awarded for rider/horse combo: WSCA, Arab/HA, and Over-All High Point**

*Walk/Trot rider/horse combination can not enter a class requiring canter or lope.*

A horse may enter only one WSCA qualifying class division per event. (Example: Cannot enter both Western Bridle Path and Western Pleasure for age group or Open Saddle Seat and Hunt Seat Pleasure for age group as WSCA qualifying. This rule does not apply to non-WSCA qualifying classes.

**SHOW CLOTHES OPTIONAL IN NON-WSCA QUALIFYING CLASSES EXCEPT NO SHOW CLOTHES IN TRI-STATE CLASSES**  
Schooling Equipment only allowed in Tri-State Classes. Tri-State classes do not qualify for Arabian Unplugged program.
